**Habitual Felon Team sends 19 offenders to prison in two days**

The DA's Habitual Felon Team convicted 19 defendants on Wednesday, February 3, and Friday, February 5, 2010. The felons pled guilty in courtroom 5310 before The Honorable W. Robert Bell, Superior Court Judge.

Thomas Adams, 47, pled guilty to felony breaking or entering and being a habitual felon; he was sentenced to 90-117 months in prison.

Santonio Brown, 28, pled guilty to possession with intent to sell or deliver cocaine and was sentenced to 19-23 months in prison.

Richard Davidson, 41, pled guilty to the sale and delivery of cocaine and was sentenced to 49-59 months in prison.

Bradley Hogue, 60, pled guilty to the sale of cocaine and was sentenced to 23-28 months in prison.

Graylina Kenion, 31, pled guilty to felony breaking or entering and being a habitual felon; he was sentenced to 101-131 months in prison.

Timmy McCullough, 33, pled guilty to the sale of cocaine and was sentenced to 20-24 months in prison.

Lisa Strickland, 45, pled guilty to possession of cocaine and was sentenced to 8-10 months in prison.

Dorothy Ali, 38, pled guilty to felony breaking or entering a motor vehicle and misdemeanor larceny; she was sentenced to 11-14 months in prison.

Yulonda Crowder, 43, pled guilty to felony possession of stolen goods and was sentenced to 16-20 months in prison.

Steve Dobie, 50, pled guilty to felony breaking or entering and being a habitual felon; he was sentenced to 101-131 months in prison.

Alfred Easterling, 45, pled guilty to the sale of cocaine and was sentenced to 20-24 months in prison.

Julius Jenkins, 26, pled guilty to possession of marijuana with the intent to sell or deliver and with selling marijuana; he was sentenced to 19-24 months in prison.

Nehemiah Mackey, 21, pled guilty to trafficking in cocaine and was sentenced to 35-42 months in prison and fined \$50,000.

Theodore McCorkle, 49, pled guilty to felony breaking or entering and was sentenced to 20-24 months in prison.

Derek McCormick, 40, pled guilty to forgery of an instrument and was sentenced to 30-36 months in prison.

Wendell Ponder, 43, pled guilty to possession with intent to sell or deliver cocaine and was sentenced to 14-17 months in prison.

Jerry Reid, 44, pled guilty to possession with intent to sell or deliver cocaine and maintaining a house/vehicle to keep/sell controlled substances; he was sentenced to 24-29 months in prison.

Charles Wilson, 55, pled guilty to possession with intent to sell or deliver heroin and to selling heroin; he was sentenced to 49-59 months in prison.

*Note: Almost all guilty pleas entered in criminal administrative court are the result of an agreed upon plea arrangement between the State and the defendant, which is then approved by the sentencing judge.
