## Habitual Felon Team sends 20 offenders to state prison in three days

The DA's Habitual Felon Team convicted 23 defendants on Tuesday March 2, Wednesday, March 3, and Friday, March 5, 2010. The felons pled guilty in courtroom 5310 before The Honorable Yvonne Mims Evans, Superior Court Judge.

Grady Kiser, 51, pled guilty to larceny of a motor vehicle and being a habitual felon; he was sentenced to 101-131 months in prison.

Ryan Lege, 28, pled guilty to possession of a stolen motor vehicle and being a habitual felon; he was sentenced to 80-105 months in prison.

Billy Meeks, 43, pled guilty to breaking and entering and he was sentenced to 101-131 months in prison.

Adrian Rowell, 45, pled guilty to possession with intent to sell or deliver cocaine within 1,000 feet of a school and was sentenced to 53-73 months in prison.

Clifford Cotton, 48, pled guilty to possession with intent to sell or deliver cocaine and delivery of cocaine; he was sentenced 36-44 months in prison.

Corey Jenkins, 25, pled guilty to two counts of possession with intent to sell or deliver cocaine and assault on a female; he was sentenced to 33-39 months in prison.

Anthony Herman, 50, pled guilty to possession of cocaine and possession of marijuana; he was sentenced to 11-14 months in prison.

Andrew Carpenter, 30, pled guilty to breaking and entering and larceny; he was sentenced to 46-58 months in prison.

William Brank, 43, pled guilty to felony larceny and was sentenced to 9-11 months in prison.

Gerald Lockhart, 49, pled guilty to conspiracy to sell cocaine and possession with intent to sell or deliver cocaine; he was sentenced to 20-24 months in prison.

Latonya Kearney, 29, pled guilty to the sale of cocaine and was sentenced to 21-26 months in prison.

Guy Stewart, 42, pled guilty to breaking and entering and larceny; he was sentenced to 11-14 months in prison.

Terrance Winborn, 48, pled guilty to three charged of the sale of cocaine and he was sentenced to 13-16 months in prison.

Anthony Duncan, 36, pled guilty to false pretense and was sentenced to 11-14 months in prison.

Aaron Crawford, 20, pled guilty to the sale of cocaine and was sentenced to 13-16 months in prison.

Larvarchio Allen, 26, pled guilty to conspiracy to sell cocaine and was sentenced to 6-8 months in prison.

Teddy Polk, 50, pled guilty to the sale of cocaine and was sentenced to 21-26 months in prison.

Antoine Lewis, 24, pled guilty to conspiracy to sell cocaine and was sentenced to 21-26 months in prison.

Byron Weaks, 45, pled guilty to possession of cocaine and was sentenced to 10-12 months in prison.

Ronnie Lindsay, 60, pled guilty to possession of cocaine and was sentenced to 9-11 months in prison.

Keith Randolph, 28, pled guilty to obtaining property by false pretense and was sentenced to 11-14 months in prison, suspended for 36 months of supervised probation with the first 9 months to be intensive supervision. He is not a <u>habitual felon under NC law</u>.

Willie Adams, 52, pled guilty attempted breaking and entering of a motor vehicle and possession of drug paraphernalia; he was sentenced to 120 days in prison, suspended for 24 months of supervised probation. He is not a <u>habitual felon under NC law</u>.

Jerral Mack, 25, pled guilty to possession with intent to sell or deliver cocaine and delivery of cocaine; he was sentenced to 8-10 months in prison, suspended for 30 months of probation with the first 6 months to be intensive supervision. He is not a habitual felon under NC law.

Note: Almost all guilty pleas entered in criminal administrative court are the result of an agreed upon plea arrangement between the State and the defendant, which is then approved by the sentencing judge.
