## **34 defendants convicted of property crimes**

CHARLOTTE, N.C. – Thirty-four defendants pled guilty to property crimes in Mecklenburg County Superior Court during the week of January 30, 2017. The defendants, who were prosecuted by the District Attorney's Crimes Against Property Team, entered their guilty pleas before The Honorable Yvonne Mims Evans, Superior Court Judge. The convictions were for crimes that included breaking or entering, larceny after breaking or entering, possession of a stolen motor vehicle, possession of a firearm by a convicted felon and habitual larceny.

Among the defendants who pled guilty were:

Duane Jackson, 49, pled guilty to two counts of felony habitual larceny. He was sentenced to 18-31 months in prison.

Robert Morrow, 31, pled guilty to 1) possession of a firearm by a convicted felon, 2) three counts of felony larceny and 3) resisting a public officer. He was sentenced to 13-25 months in prison.

Jeri Smith, 33, pled guilty to 1) felony breaking or entering and 2) larceny after breaking or entering. She was sentenced to 9-20 months in prison.

Daveon Andrews, 17, pled guilty to 1) felony larceny and 2) breaking or entering a motor vehicle. He was sentenced to 9-20 months in prison.

Domonique Chisholm, 23, pled guilty to 1) felony breaking or entering and 2) larceny after breaking or entering. He was sentenced to 8-19 months in prison. In September 2013, the victim returned to his Charlotte residence and saw that a front window had been smashed and that someone had broken into his house and taken two cameras, a laptop and a change jar. Charlotte-Mecklenburg police noticed blood on the shattered glass and the curtains, which were collected and tested by crime lab analysts. DNA testing indicated that the blood matched that of Chisholm, who was later arrested and charged with the crime.

Jonathan Lovero, 32, pled guilty to 1) breaking or entering a trailer, 2) felony possession of stolen goods and 3) misdemeanor larceny. He was sentenced to 8-19 months in prison.

Xavid Rivera, 19, pled guilty to 1) felony breaking or entering and 2) larceny after breaking or entering. He was sentenced to 7-18 months in prison.

Jatarius Jones, 16, pled guilty to 1) felony breaking or entering and 2) larceny after breaking or entering. He was sentenced to 6-17 months in prison.

Cail Glaze, 44, pled guilty to 1) possession of a stolen motor vehicle and 2) breaking or entering a motor vehicle. He was sentenced to 6-17 months in prison.

Shakor Daniels, 18, pled guilty to two counts of breaking or entering a motor vehicle. He was sentenced to 5-15 months in prison.

Aaron Vanwormer, 34, pled guilty to felony larceny. He was sentenced to 5-15 months in prison.

*Note: Almost all guilty pleas entered in criminal administrative court are the result of an agreed upon plea arrangement between the State and the defendant, which is then approved by the sentencing judge.
