Armed robbers convicted at trial; others plead guilty

CHARLOTTE, N.C. – The DA's Crimes Against Persons Team called three cases for trial the week of September 19, 2011. The trials were held in courtroom 5370 before the Honorable Richard D. Boner, Senior Resident Superior Court Judge, and in courtroom 5150 before the Honorable Hugh B. Lewis, Superior Court Judge.

Paul Glover, 22, was tried for 1) robbery with a dangerous weapon, 2) conspiracy to commit robbery with a dangerous weapon, and 3) felony breaking or entering. The jury returned verdicts of *guilty* on all charges. Judge Lewis sentenced Glover to 70-93 months in prison. Judge Lewis stayed the sentence pending the defendant's appeal, and Glover may be released from custody upon posting a \$25,000 bond. Glover was on probation for conspiracy to commit robbery with a dangerous weapon when he committed this robbery.

Catrell Holloway, 20, was tried for 1) attempted robbery with a dangerous weapon and 2) conspiracy to commit robbery with a dangerous weapon. The jury returned verdicts of *guilty* of attempted robbery with a dangerous weapon and *not guilty* of conspiracy to commit robbery with a dangerous weapon. Judge Boner sentenced Holloway to 72-96 months in prison. Holloway's criminal history included a conviction for common law robbery.

Dominik Parks, 20, was tried for 1) first-degree kidnapping, 2) robbery with a dangerous weapon, and 3) conspiracy to commit robbery with a dangerous weapon. After the State presented its evidence, which included the testimony of 10 witnesses, Parks decided to plead guilty as charged. Judge Boner sentenced Parks to 60-81 months in prison.

Jervontez Leak, 19, pled guilty to 1) two counts of robbery with a dangerous weapon and 2) one count of conspiracy to commit robbery with a dangerous weapon. Judge Lewis sentenced Leak to 75-108 months in prison.

Lemontay Phillips, 32, pled guilty to 1) assault with a deadly weapon with intent to kill inflicting serious injury and 2) discharging a firearm into a moving vehicle. Judge Boner sentenced Phillips to 58-79 months in prison.

Dexter Ray Campbell, 23, pled guilty to 1) two counts of robbery with a dangerous weapon and 2) one count of conspiracy to commit robbery with a dangerous weapon. Judge Boner sentenced Campbell to 48-67 months in prison.

Lamar Walker, 21, pled guilty to common law robbery. Judge Lewis sentenced Walker to 16-20 months in prison.
