Sex offenders among 36 defendants convicted by Crimes Against Persons Team

CHARLOTTE, N.C. – Thirty-six defendants, including sex offenders, were convicted by the Mecklenburg County District Attorney's Crimes Against Persons Team during the week of July 3, 2017. The defendants entered their guilty pleas in courtroom 5350 before The Honorable Robert C. Ervin, Superior Court Judge. Court was not held on July 4, 2017, in observance of Independence Day. Among those convicted and sent to prison were:

Ronald Crawford, 57, pled guilty to attempted statutory sex offense with a child. Crawford was sentenced to 125-210 months in prison. Upon his release from prison, Crawford must register as a sex offender for 30 years.

Antonio Glenn, 28, pled guilty to 1) second-degree sex offense and 2) first-degree kidnapping. Glenn was sentenced to 88-166 months in prison. Upon his release from prison, Glenn must register as a sex offender and participate in satellite-based monitoring for the rest of his life.

Sherif Mankarious, 36, pled guilty to 1) attempted second-degree rape, 2) second-degree kidnapping and 3) felony breaking or entering. Mankarious was sentenced to 48-118 months in prison. Upon his release from prison, Mankarious must register as a sex offender for 30 years.

James Crowe, 21, pled guilty to two counts of indecent liberties with a child. Crowe was sentenced to 32-58 months in prison. Upon his release from prison, Crowe must register as a sex offender for 30 years.

James Roseboro, 47, pled guilty to second-degree kidnapping. Roseboro was sentenced to 30-48 months in prison.

Lamariee Harvell, 21, pled guilty to 1) conspiracy to commit robbery with a dangerous weapon and 2) felony flee to elude arrest. Harvell was sentenced to a total of 30-57 months in prison.

Jairus Stevenson, 31, pled guilty to possession of a firearm by a convicted felon. Stevenson was sentenced to 15-27 months in prison.

Shaynicia Lewis, 21, pled guilty to 1) common law robbery and 2) conspiracy to commit common law robbery. Lewis was sentenced to 12-24 months in prison. She was also sentenced to an additional 6-17 months in prison; that sentence was suspended pending her successful completion of 36 months of supervised probation.

Note: Almost all guilty pleas entered in criminal administrative court are the result of an agreed upon plea arrangement between the State and the defendant, which is then approved by the sentencing judge.
