Habitual Felon Team convicts 7 defendants

CHARLOTTE, N.C. – The Mecklenburg County District Attorney's Habitual Felon Team convicted 7 defendants during administrative sessions that took place the week of July 1, 2024. Five of those defendants were sentenced to prison. The defendants entered their guilty pleas in courtroom 5310 before The Honorable Carla Archie, Superior Court Judge.

Deshun Robinson, 32, pled guilty to 1) three counts of felony breaking or entering and 2) three counts of felony larceny. Robinson also admitted to one count of the status offense of habitual breaking or entering. Judge Archie sentenced Robinson to 50-72 months in prison. Robinson also admitted to violating the terms of his probation for a previous conviction. Judge Archie revoked that probation and activated his suspended sentence of 15-27 months. That sentence will run concurrent to the new sentence.

In three separate incidents from July 2023 through September 2023, Robinson broke into car dealerships at night, located keys to vehicles, then used the keys to drive away or attempt to drive away the vehicles.

Gary Crawford, 38, pled guilty to 1) obtaining property by false pretense and 2) felony possession of stolen goods. Judge Archie sentenced him to 8-19 months in prison.

Andre Newton, 54, pled guilty to attempted trafficking in cocaine. Judge Archie sentenced him to 25-39 months in prison.

Mark Henderson, 53, pled guilty to 1) felony breaking or entering and 2) larceny after breaking or entering. Henderson also admitted to one count of the status of habitual breaking or entering. Judge Archie sentenced him to 40-60 months in prison. Henderson also admitted to violating the terms of his probation for a previous conviction. Judge Archie revoked that probation and activated his suspended sentence of 15-27 months. That sentence will run concurrent to the new sentence.

Tyrone Sharperson, 30, pled guilty to 1) selling methamphetamine and 2) selling or delivering cocaine. Judge Archie sentenced him to 15-27 months in prison.

Daniel Summers, 45, pled guilty to possession of a firearm by a convicted felon. Judge Archie sentenced him to 13-25 months in prison; that sentence was suspended pending his completion of 24 months of supervised probation.

Jimareo Sherrill, 31, pled guilty to felony financial card fraud. Judge Archie sentenced him to 4-14 months in prison; that sentence was suspended pending his completion of 18 months of supervised probation.
