## 21 convicted during administrative court sessions

CHARLOTTE, N.C. – The Mecklenburg County District Attorney's Office convicted 21 defendants during recent administrative court sessions in Superior Court held the week of February 24, 2025. The cases were prosecuted by the Mecklenburg County District Attorney's Homicide and Habitual Felon Teams. The defendants entered their guilty pleas in courtroom 5310 before the Honorable Carla N. Archie, Superior Court Judge.

Among those convicted were:

Ty-Lek Hamilton, 25, pled guilty to 1) second-degree murder and 2) robbery with a dangerous weapon. Judge Archie sentenced him to 300-372 months in prison for the second-degree murder charge and a consecutive sentence of 64-89 months in prison for the robbery charge.

Samuel Childers, 50, pled guilty to 1) three counts of felony breaking or entering and 2) being a habitual felon. Judge Archie sentenced him to 77-105 months in prison.

Derek Rhodes, 46, pled guilty to felony larceny. Judge Archie sentenced him to 20-33 months in prison.

Steven Dubose, 39, pled guilty to felony flee to elude arrest with a motor vehicle. Judge Archie sentenced him to 15-27 months in prison.

Michael Dugger, 38, pled guilty to three counts of felony larceny. Judge Archie sentenced him to two consecutive sentences of 14-26 months each.

Cameron Fleming, 26, pled guilty to 1) assault with a deadly weapon inflicting serious injury and 2) possession of a weapon by a prisoner. Judge Archie sentenced him to 44-65 months in prison.

Rico Adams, 46, pled guilty to 1) breaking or entering a motor vehicle and 2) conspiracy to commit felony larceny. Judge Archie sentenced him to 10-21 months in prison.

Everette Anderson, 52, pled guilty to 1) larceny from the person, 2) breaking or entering a motor vehicle, and 3) misdemeanor larceny. Judge Archie sentenced him to 16-29 months in prison.

Darrell Mitchell, 56, pled guilty to 1) felony breaking or entering, 2) larceny after breaking or entering, and 3) being a habitual felon. Judge Archie sentenced him to 67-93 months in prison.

Joshua Russ, 29, pled guilty to 1) common law robbery and 2) misdemeanor larceny. Judge Archie sentenced him to 15-27 months in prison.

Kelvin McKinney, 60, pled guilty to habitual misdemeanor assault. Judge Archie sentence him to 16-29 months in prison.

Raymond Calebro, 34, pled guilty to 1) two counts of felony breaking or entering, 2) felony flee to elude arrest with a motor vehicle, 3) larceny after breaking or entering, 4) larceny of a motor vehicle, and 5) being a habitual felon. Judge Archie sentenced him to 58-82 months in prison.
